## September Recap

### Alabama Arise Organizer Formeeca Tripp Updates LWVEA Attendees on Key Legislative Issues

Have you noticed any changes in your grocery bills? **Alabama Arise**, a statewide non-partisan policy advocacy organization, is working to eliminate Alabama's statewide grocery tax. Reduced from 4% to 3% in 2023, the state-level tax now has been further reduced to 2%, set to take effect by the end of August 2025. While it is a big win, "we're hoping to bring that number down to zero," said **Formeeca Tripp**, Alabama Arise's Senior Organizer for Southeast Alabama.

On September 15th, in this season's first installment of LWVEA's monthly **Civic Leader Meet and Greet Series**, Ms. Tripp briefed attendees on Alabama Arise's work to untax groceries, expand Medicaid coverage for Alabamians, increase children's access to food, and more. She also discussed what impacts the Trump administration's "Big Beautiful Bill" (or OBBBA) will have on these issues for Alabamians.

#### **Medicaid**

For those on Medicaid, "we do not expect anyone in Alabama to be immediately kicked off their health coverage," Ms. Tripp said, explaining that the new work requirements are unlikely to affect individuals at this time. She added, however, that "the key incentives that were created to encourage Medicaid expansion are gone, and the key tool Alabama uses to help fund our state's share of Medicaid is now severely restricted." Ms. Tripp noted that rural Alabama hospitals (of which 14 have closed since 2010 and at least 20 more are at risk) will face further financial strain under OBBBA since more uninsured patients will increase uncompensated care costs for providers.

#### **Marketplace Health Plans**

Alabama Arise projects that 130,000 Alabamians could lose coverage from Marketplace plans offered on healthcare.gov due to OBBBA's



elimination of subsidies designed to make the plans more affordable. Monthly premiums will double in 2026 for many people who use the Marketplace plans, Ms. Tripp said.

#### **SNAP**

"We do not expect anyone in Alabama to immediately lose or see reduced SNAP benefits," said Ms. Tripp. She advised SNAP recipients to continue as usual but to keep a lookout for any changes. She cautioned that as soon as the USDA issues guidance to the states, many veterans, people experiencing homelessness, and young adults aged out of foster care may have to comply with work reporting requirements.

## National Voter Registration Day Bonanza

In honor of National Voter Registration Day, which fell on Tuesday, September 16 this year, LWVEA held not one but THREE voter registration drive events in the Auburn/Opelika area! Volunteers registered residents to vote at Southern Union State Community College, Auburn University, and Auburn High School.

Volunteers especially enjoyed registering students at Auburn High School. While students of age had the opportunity to register, all students were invited to participate in a mock vote: Which of the following should be enacted as a new rule for Fridays? 1) No tests; 2) Extended lunch period; or 3) Write-in option.

Option 2 won with a plurality of the vote (42.5%). 120 students participated in the mock election!
